Dear Nebraska Secondary Art Teacher,

In order to increase the quantity of secondary work submitted to the Congressional Art Caucus Competition (CAC), we are asking that you earmark two of your submitted NSVAC works for CAC. This simply saves you from making two separate mailings for NSVAC and CAC like you had to in the past AND work can be in both events. The works earmarked for CAC will be judged during NSVAC and those chosen will be honored during the February 27th ceremony in Omaha.

Important Dates:

- NSVAC/CAC submission deadline is Friday, January 15, 2010 to the OPS Teacher Administration Center.
- NSVAC Awards ceremony is on February 27, 2010 at the OPS Teacher Administration Center.

Checklist:

1. Artwork may be submitted by instructors at public and private schools, private studios, museum programs and/or similar programs.
2. One work per student. No framed paintings on canvas and no three-dimensional art.
3. Send digital images according to NSVAC guidelines and mark on the entry form it is also for CAC.
4. Complete the following documents and place in an envelope included with the artwork:
 - ~ Congressional Arts Caucus Competition (CAC) "An Artistic Discovery" entry and permission form
 - ~ Artist signature on artwork
